


Optocoupler with Phototransistor Output


Description

The CNY64/ 65/ 66 consist of a phototransistor optically coupled to a gallium arsenide infrared-emitting diode in a 4-lead plastic package.


The single components are mounted in opposite one another, providing a distance between input and output for highest safety requirements of > 3 mm.

Application

Circuits for safe protective separation against electrical shock according to safety class II (reinforced isolation):

- For application class I - IV at mains voltage ≤ 300 V
- For application class I - IV at mains voltage ≤ 600 V
- For application class I - III at mains voltage ≤ 1000 V according to VDE 0884, table 2, suitable for:








Figure 1. Test circuit, non-saturated operation




Figure 2. Test circuit, saturated operation




Figure 3. Test pulse diagram for sample test according to DIN VDE 0884




Figure 4. Total Power Dissipation vs. Ambient Temperature




Figure 7. Collector Dark Current vs. Ambient Temperature




Figure 5. Forward Current vs. Forward Voltage




Figure 8. Collector Current vs. Forward Current




Figure 6. Rel. Current Transfer Ratio vs. Ambient Temperature




Figure 9. Collector Current vs. Collector Emitter Voltage




Figure 10. Collector Emitter Sat. Voltage vs. Collector Current




Figure 12. Turn on / off Time vs. Forward Current




Figure 11. Current Transfer Ratio vs. Forward Current






Figure 13. Turn on / off Time vs. Collector Current


Dimensions of CNY64 in mm
